# Minutes of the Annual Meeting of Adlington Town Council held on Monday 13th May 2019 In Adlington Library, Railway Road, Adlington commencing at 7:30pm

### 1 Election of Town Mayor

It was resolved that the Mayor's allowance would be £750, the budget amount which was previously agreed by the Council as representing the necessary expenditure for the year in office.

It was resolved that as nine Councillors were elected in May and the Clerk holds the relevant qualification the Council is eligible for the General Power of Competence.
